The Academy of Science of South Africa (ASSAf) has recently published *The 2nd Biennial Report on Climate Change* which it will disseminate through this session. The InterAcademy Partnership (IAP) which is a global network of academies has produced a report entitled *Evidence-informed Policy for Tackling Adverse Climate Change Effects on Health: Linking Regional and Global Assessments of Science to Catalyse Action.* The report was as a result of work was done through the regional members of IAP of whom ASSAf is a member. These documents are available for use at the COP26 and beyond as countries address climate change as a wicked problem that has a global impact.
